## 73rd ANNIVERSARY

The Colombo Plan celebrated its  $73^{\circ}$  Anniversary on  $4^{\circ}$  July 2024 at the Sheraton Hotel, Colombo, with a focus on the launch of the Training of Trainers (ToT) activity on Dignified Menstruation. This week-long initiative was conducted to coincide with the anniversary celebrations.



During the event, the Secretary-General of the Colombo Plan, The ToT was conducted under the Gender Affairs Program in collaboration with the Global South Coalition for Dignified Menstruation. The program brought together 26 participants from 13 member countries, focusing on empowering women and advancing menstrual health advocacy.

This initiative reflects the Colombo Plan's commitment to Sustainable Development Goal 5, emphasizing the elimination of discrimination and the promotion of women's rights in both private and public spheres.

The celebration underscored the Colombo Plan's ongoing mission to make meaningful contributions to global development and gender empowerment.

### MARITIME ADVISORY PROGRAMME

Strengthening Sri Lanka's maritime capacity through training, global exposure, and policy engagement

The Maritime Advisory Programme (MAP), funded by the U.S. Embassy in Colombo and implemented by The Colombo Plan in collaboration with the Sri Lanka Ports Authority (SLPA), continues strengthening Sri Lanka's maritime capacity through professional development, international exposure, and policy engagement. MAP has supported key initiatives aligned with global standards and development goals, the programme focuses on enhancing skills in areas such as cybersecurity, international benchmarking, and institutional collaboration.

Key Developments from June 2024 to June 2025

#### Skill Connect Training: Effective Negotiation for Maritime Professionals

In July 2024, MAP conducted a two-day training on "Effective Negotiation for Maritime Professionals" at the Courtyard by Marriott in Colombo. Facilitated by Mr. Tissa Dissanayaka. The trainingwasdesignedfor SLPA personnel, it was mainly targeting practical negotiation strategies to improve communication and decision making skills in the maritime industry.

## Cybersecurity Workshop: "Navigating Cyber Threats"

In November 2024, MAP hosted a two-day workshop titled "Navigating Cyber Threats," attended by 45 SLPA participants. Led by experts from Experion Global, the sessions focused on cybersecurity in port operations. The workshop focused on key areas such as the ISO 27001 framework, identifying cybersecurity risks, managing incident response included case studies and interactive group exercises to enhance practical understanding.

#### Sri Lanka Ports Authority Delegation Attends CIMC 2024

In the same month, a ten-member SLPA delegation participated in the Colombo International Maritime & Longston Conference (CIMC) at the Coinness Grand Hotel. The event facilitated regional and global dialogue on container trade flows, port infrastructure, supply chain resilience, digitalisation, and sustainability in the maritime industry.

## Technical Visit and Participation at TOC Europe 2025 in Rotterdam

In June 2025, MAP supported another SLPA delegation to attend the Terminal Operator Conference in Rotterdam. This included a technical visit to the Port of Rotterdam, one of Europe's leading sustainable ports offering direct exposure to advanced port technologies.

The conference was based on trade, tariffs, its tensions, sustainable growth and investment in technology. Throughout the conference, SLPA officials engaged with global experts on container terminal innovation, digital transformation in port logistics, environmental practices, and evolving international trade dynamics. The insights gained are expected to cultivate and grow SLPA's continuing development initiatives including the Colombo East Container Terminal.

Delegates also met with suppliers from around the world, including eleven suppliers from the U.S., to explore potential partnerships and evaluate solutions applicable to SLPA operations in Sri Lanka.

## Peer Advisory Missions and Policy Collaboration

Looking ahead, MAP remains committed to supporting SLPA's continued growth through expert collaboration and policy engagement. Two upcoming Peer Advisory Missions will focus on advancing SLPA's operational modernization and cybersecurity preparedness, reinforcing Sri Lanka's maritime sector development in line with international best practices.





## CAPACITY BUILDING PROGRAMME

Human Resource Development (HRD) plays an essential role in the development process of a country. Therefore, the Colombo Plan endeavours to enhance Human Resource Development initiatives in the member countries through its Capacity Building Programmes. The Colombo Plan provides short-term training courses, workshops, scholarships and Master's degree programmes under the wings of its Capacity Building Programme. All activities are fully or partially funded on cost sharing basis by donors in the Colombo Plan member countries and other International Organizations.

## DRUG ADVISORY PROGRAMME

#### AT A GLANCE

The Drug Advisory Programme (DAP) of the Colombo Plan, established in 1973 during a consultative committee meeting held in Wellington, New Zealand, is a pioneering initiative dedicated to addressing global challenges related to drug concerns and related issues.

Today, DAP stands as the Colombo Plan's flagship programme operating across over 80 countries, and playing a leading role in both drug demand and drug supply reduction.

DAP'S GLOBAL OUTPEACH IN



The Drug Advisory Programme is primarily funded by the Bureau of International Narcotics and Law Enforcement Affairs (INL) of the U.S. Department of State. In addition to this core support, DAP receives voluntary contributions from several member countries, including India, Japan, Malaysia, the Maldives, Pakistan, Singapore, South Korea, and Thailand, DAP implements various initiatives on a cost-sharing basis in collaboration with partner countries around the world.

#### DRUG DEMAND REDUCTION (DDR)

The Colombo Plan's Drug Demand Reduction (DDR) initiative The Colombo Plans Drug Demand Reduction (DDR) initiative focuses on preventing and reducing substance use through evidence-based strategies, capacity building, and international collaboration. #### Curriculum-based Capacity Building – Prevention, Treatment, and Recovery

DAP provides technical assistance in terms of trainings to empower substance use disorder professionals in government & non-government settings, enabling them to implement effective, evidence-based strategies.

### New update on DDR Trainings

On 13 June 2025, DAP signed an agreement with the Government of Uruguay to strengthen the country's capacity in Drug Demand Reduction. The agreement focuses on delivering specialized training to professionalize the druguse workforce and build sustainable, in-country capacity.

#### Support for Drug Treatment and Rehabilitati

In Afghanistan, DAP provides support to 24 treatment centers across six provinces, delivering inpatient, outpatient, and home-based treatment services to approximately 3.500 individuals each year.

#### DAP approved Training Providers

The Colombo Plan recognizes and accredits key partner organizations from various countries as official Training Providers (TPs) for the dissemination of its Universal Curricula in their respective countries. As of now, DAP has 79 training providers from around the world.

## DRUG SUPPLY REDUCTION (DSR)

The Colombo Plan has emerged as a global leader in tackling the dangers posed by toxic adulterants and synthetic drugs. Through its Drug Supply Reduction (DSR) initiatives, the Colombo Plan is working with governments and top scientific agencies to detect, analyze, and prevent the spread of harmful substances hidden in illicit drugs.

The Supply Reduction Programme has pioneered;

- The world's first instant test kit for streetlevel drug adulterants,
- A portable drug testing device that detects multiple compounds in seconds,
- A Sentinel early warning system to issue alerts on newly emerging threats.

## Global Toxic Adulterants and Sentinel Projects

The Colombo Plan's Global Toxic Adulterant and Sentinel Projects focus on identifying and monitoring toxic adulterants and emerging synthetic substances in drug supplies. By utilizing advanced testing technologies, these initiatives aim to address the rising global threat of dangerous chemical additives in illicit drugs. The projects play a critical role in early warning. prevention, and public health protection

More on Supply Reduction...

The DSR Programme launched a new project in 2024 for South Asia which focuses on upgrading forensic labs in Sri Lanka, Nepal, Bangladesh, and the Maldives with advanced equipment and training to better detect synthetic drugs.

International Toxic Adulterant Database (ITAD) is a global platform developed by the Colombo Plan to track toxic adulterants and emerging drug combinations.

#### Toxic Adulterant Alerts: Addressing Emerging **Drug Threats**

In collaboration with the Center for Forensic Science Research and Education (CFSRE), the Colombo Plan has issued a series of toxic

adulterant alerts to raise global awareness about dangerous substances increasingly found in the illicit drug supply. Recent alerts include Nitazenes (January 2025), and BTMPS and Tetramethylfentanyl-related substances (May 2025), highlighting the evolving threats in the global drug landscape

2025: The Universal Nurses Addiction Curricula (UNAC) was launched in June 2025, marking the first globally standardized training resource designed specifically for nurses working in substance use disorder treatment settings

May 2025: "Managing Drug Use Disorder Treatment Services in Line with International Key Quality Standards: A Handbook for Managers." Released in English and Spanish during a webinar on 21May 2025, the handbook offers practical guidance to help treatment progress improve service until and nation. centres improve service quality and patient

September 2024: The 11th Asian Youth Forum was held in Kochi, India, from 16-20 September 2024, welcoming 150 youth leaders from 13
